Supply and Repair Services of Gas Turbine Parts

for EGAT Accepted Gas Turbine Parts Vendor Lists

1. Introduction

Electricity Generating Authority of Thailand hereafter referred to as EGAT is Thailand's leading state-owned power utility under the Ministry of Energy, with its principal role in power development planning and electricity generating and transmitting to meet the country's requirements.

To enhance EGAT's procurement efficiency and to support the electricity generating under Thailand's Power Development Plan, EGAT establishes Pre-Qualification to select the vendors who are qualified to be registered as EGAT's Vendors for Supply and Repair services of Gas Turbine Parts (Pre-Qualified Vendors).

3. Potential Candidates means the vendors of Gas Turbine Parts who register, propose the Pre-Qualification Proposal, and in case of qualified with EGAT requirements in compliance with this Invitation and Pre-Qualification Documents, will be registered in the "EGAT Accepted Gas Turbine Parts Vendor Lists".

4. Technical and Commercial Requirements

The qualifications of Potential Candidates shall be consisting of the technical and commercial requirements in compliance with the Invitation and Pre-Qualification Documents as per details below:

4.1 <u>Technical Requirements</u>

The technical requirements of Potential Candidates shall be required to evidence their compliance with this Invitation and Pre-Qualification Documents.

4.2 <u>Commercial Requirements</u>

The commercial requirements of Potential Candidates shall be required to evidence that they are wellestablished and maintain a permanent place of business by submitting the documents, including but not limited to the following documents:

- A certified copy of affidavit of incorporation
- Memorandum of association
- Certified copy of registration for value added tax

Potential Candidates who fail to provide information which demonstrates their compliance with any of the technical requirements and commercial requirements to EGAT's satisfaction shall not be eligible to be registered as EGAT's Pre-Qualified Vendors.

5. <u>Pre-Qualification Process and Revocation Process for Supply and Repair Services of Gas Turbine Parts</u>

- 5.1 Pre-Qualification Process for Supply and Repair Services of Gas Turbine Parts
 - i. The Pre-Qualification documents including technical and commercial requirements are available for download free of charge at website <u>https://fprocurement.egat.co.th/prequalification/en</u>.
 - ii. Potential Candidates who will participate in the Pre-Qualification Process shall complete the registration at website <u>https://fprocurement.egat.co.th/prequalification/en</u> to be registered candidates prior to the submittal of Pre-Qualification Proposal together with the related documents or other supporting documents to substantiate their qualifications in compliance with this Pre-Qualification Documents.
 - iii. EGAT's Pre-Qualification Evaluating Committee will consider the Pre-Qualification Proposal and/or visit the Potential Candidates' workshop facilities (Workshop Visit).
 - iv. In case any information in the Pre-Qualification Proposal is found insufficient for EGAT's consideration, such Potential Candidates will be required to submit or inform supplemental information during and after the Pre-qualification Process for the purpose of EGAT's consideration within the date specified by EGAT's Pre-Qualification Evaluating Committee.
 - v. In case Potential Candidates will not submit supplemental information as requested by EGAT, or the supplemental information submitted is still found insufficient for EGAT's satisfaction, such Potential Candidates shall not be eligible to be registered as EGAT's Pre-Qualified Vendors.

EGAT will announce "EGAT Accepted Gas Turbine Parts Vendor Lists" at website <u>https://fprocurement.egat.co.th/prequalification/en</u> after EGAT's Pre-Qualification Evaluating Committee has concluded Pre-qualification Process. The disqualified Potential Candidates will be informed individually via our notification letter.

- vi. EGAT reserves the right to cancel the Invitation and Pre-Qualification Documents at any time upon EGAT's notification. Potential Candidates shall not be entitled to claim EGAT for any losses and/or damages in this connection.
- vii. The Pre-Qualified Vendors for Supply and Repair Services of Gas Turbine Parts shall remain in the "EGAT Accepted Gas Turbine Parts Vendor Lists" until they are revoked as specified in Article 5.3
- viii. After our announcement of the "EGAT Accepted Gas Turbine Parts Vendor Lists", for each specific Parts Model specified in Article 2., only Vendors for Supply or Repair Services of Gas Turbine Parts in the Lists may submit their proposals during EGAT's procurement stage.
- 5.2 The Pre-Qualification for the new Vendors for Supply and Repair Services of Gas Turbine Parts and the re-evaluation of the existing Vendors will be conducted every 3 years or as necessary.

5.3 <u>Revocation Process of Pre-Qualified Vendors for Supply and Repair Services of Gas Turbine Parts</u>

- 5.3.1 Pre-Qualified Vendors for Supply and Repair Services of Gas Turbine Parts shall be revoked at any time from the "EGAT Accepted Gas Turbine Parts Vendor Lists" under any of the following conditions:
 - a) Being named in the List of Work Abandoners published by government agencies or by EGAT; or
 - b) Being a contractor, whose contract is terminated by EGAT, or having defect(s) or failure(s) in his work that cause any damage or loss to EGAT; or
 - c) Having pending claim(s) by EGAT against him; or
 - d) The Parts provided having defect(s) which make the Parts unable to be put into use in EGAT's system, or having defect(s) or failure(s) in his work that cause any damage to EGAT;

EGAT reserves the right to revoke such Pre-Qualified Vendor in "EGAT Accepted Gas Turbine Parts Vendor Lists" at any time upon our consideration.

5.3.2 EGAT will inform the revocation result of Pre-Qualified Vendors for Supply and Repair Services of Gas Turbine Parts to the revoked Vendors. As a result, "EGAT Accepted Gas Turbine Parts Vendor Lists" will be updated and announced at the below website: <u>https://fprocurement.egat.co.th/prequalification/en</u>. 5.3.3 In case the Pre-Qualified Vendors for Supply and Repair Services of Gas Turbine Parts are revoked from the "EGAT Accepted Gas Turbine Parts Vendor Lists" during the time in which the revoked Vendors are proposing in a specific bid, their associated proposals shall not be eligible for such bid and shall be rejected.

The revoked Pre-Qualified Vendors shall not be entitled to claim EGAT for any losses and/or damages in this connection.

6 Preparation of Pre-Qualification Proposal

- 6.1 Pre-Qualification Proposal shall be those of the proposed entity only. All information, documents, and other evidences presented by Potential Candidates shall be certified as true by their authorized representative. If any candidate presents false information or false documents or false evidence to EGAT, those of such candidate shall not be considered in EGAT's Pre-Qualification process.
- 6.2 Potential Candidates shall submit their Pre-Qualification Proposal in accordance with technical and commercial requirements as stipulated in Article 4. The Pre-Qualification Proposal shall be furnished one (1) set of electronic file(s) or soft copy (PDF format or compressed files in Zip formats), not exceeding twenty-five (25) megabyte (MB) per email message, manually signed in ink or digitally signed by a person or persons duly authorized and affixed with corporate seal (if any), to EGAT no later than the Pre-Qualification Proposal Submission Date.

The letter of authorization shall be indicated by written power-of-attorney accompanying the proposal.

In case any Potential Candidate proposes two (2) or more Parts Models, such Potential Candidate may submit only one (1) set of electronic file(s) of evidence(s) for commercial requirements specified in Article 4.

Potential Candidates may redact any confidential information set out in Pre-Qualification Proposals but they should ensure that sufficient unredacted information therein is provided to enable EGAT to evaluate the Pre-Qualification Proposal during EGAT's Pre-Qualification process.

6.3 Potential Candidates who submit Pre-Qualification Proposal must be a registrant of the Pre-Qualification of Vendors for Supply and Repair Services of Gas Turbine Parts.

In case of a change of Potential Candidate's name, the registrant shall notify EGAT the change of the name in writing prior to the Pre-Qualification Proposal submission. EGAT reserves the right to consider only the Pre-Qualification Proposal proposed by a registrant of the Pre-Qualification of Vendors for Supply and Repair Services of Gas Turbine Parts.

- 6.4 All Pre-Qualification Proposal, information, clarifications, correspondences and other written documentation shall be in English.
- 6.5 Potential Candidate's Contact Person

Potential Candidates shall inform their Contact Person in Pre-Qualification Form for Supply and Repair Services of Gas Turbine Parts.

Written clarification from any other person or verbal contact shall not be accepted.

6.6 Potential Candidates shall bear all costs associated with the preparation and submission of his Pre-Qualification Proposal and EGAT will in no case be liable for those costs, regardless of the conduct or outcome of the Pre-Qualification process.
