2. Documents to be submitted

Potential Candidates who wish to attend the Pre-Qualification shall complete EGAT Pre-Qualification Form for Manufacture and Repair Services of Gas Turbine Parts and submit supporting documents for each requirement of General Qualification and Essential Specific Qualification as specified in the attached Form within the due date.

3. Evaluation Criteria

- 3.1 The General Qualification shall be primarily evaluated. In case a candidate cannot satisfy all requirements of General Qualification, such candidate shall be disqualified.
- 3.2 The Essential Specific Qualification will be evaluated only after a candidate obtains all General Qualification. The evaluation can be conducted with submission of documents and/or by visiting a candidate's workshop. The full score for this evaluation is 100 for manufacturing services and 100 for repairing services.
- 3.3 After EGAT's Pre-Qualification Evaluation Committee has concluded the evaluation, EGAT will announce the "EGAT Accepted Gas Turbine Parts Vendor Lists" at website http://fprocurement.egat.co.th/pre_qualification, and candidates who score 60 or more and considered as qualified vendors shall be notified in writing.
- 4. The benefits of vendors who are named in "EGAT Accepted Gas Turbine Parts Vendor Lists" are as follows:
 - 4.1 Receiving requests for proposal for Manufacture or Repair Services of Gas Turbine Parts that you have been listed.
 - 4.2 Being able to offer a proposal for EGAT's each request for proposal for Manufacture or Repair Services of Gas Turbine Parts that you have been listed.
- 5. Liabilities of successful vendors as EGAT's contractors
 - 5.1 Delivering performance conforming to criteria that each Vendor commits himself to in his Pre-qualification Proposal.
 - 5.2 Fulfilling a contractual obligation.
- 6. Revocation Criteria of Pre-Qualification Vendors
 - 6.1 EGAT reserves the right to revoke Pre-qualification vendors at any time from the "EGAT Accepted Gas Turbine Parts Vendor Lists" under any of the following conditions:
 - 6.1.1 Being named in the List of Work Abandoners published by the Permanent Secretary, Ministry of Finance and/or in the Debarment List and/or in the List of Work Abandoners by EGAT.
 - 6.1.2 Being a contractor, whose contract is terminated by EGAT, or having defect(s) or failure(s) in his work that cause any damage or loss to EGAT.
 - 6.1.3 Having pending claim(s) by EGAT against him.
 - 6.1.4 Having defect(s) which make the Parts unable to be put into use in EGAT's system or cause any damage to EGAT.

6.2 EGAT reserves the right to not consider Vendor(s) who have been revoked from the "EGAT Accepted Gas Turbine Parts Vendor Lists" under the condition 6.1 in any further Pre-Qualification evaluation. Exception is made for the condition 6.1.3 in case that such Vendor(s) have resolved all pending claims.
